Notice is hereby given that on March 8, 2016, at 6:30 PM, or as soon as possible thereafter, in the Town Hall, 645 Holbrook, Erie, Colorado, or at such place and time as the hearing may be adjourned to, a PUBLIC HEARING will be held upon the application made by the Town of Erie, Colorado, a Municipal Corporation, for the purpose of considering Initial Zoning pursuant to the Codes of the Town of Erie and applicable State Statutes.

The affected property is located at: East of County Line Road, west of Erie Air Park and north of the Lafayette Waste Water Facility

The legal description of the property is:

A PARCEL OF LAND SITUATED IN THE SOUTHEAST QUARTER OF SECTION 36, TOWNSHIP 1 NORTH, RANGE 69 WEST OF THE 6TH PRINCIPAL MERIDIAN, AND A PARCEL OF LAND BEING PART OF THE PLAT OF A PORTION OF THE NORTHEAST $\frac{1}{4}$ OF THE SOUTHEAST $\frac{1}{4}$ OF SECTION 36, AS RECORDED AT THE OFFICE OF THE BOULDER COUNTY CLERK AND RECORDER ON JANUARY 17, 1908 IN PLAT BOOK 3, PAGE 37, COUNTY OF BOULDER, STATE OF COLORADO, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTHEAST CORNER OF LOT 16 OF SAID PLAT;
THENCE N89°27'22"E A DISTANCE OF 33.36 FEET TO THE EAST QUARTER CORNER OF SAID SECTION 36;
THENCE S00°48'43"W ALONG THE EAST LINE OF SAID SOUTHEAST QUARTER AND ALONG THE WEST BOUNDARY OF ERIE AIR PARK SUBDIVISION A DISTANCE OF 676.55 FEET;
THENCE N89°19'50"W A DISTANCE OF 31.63 FEET;
THENCE S88°21'05"W A DISTANCE OF 39.64 FEET;
THENCE N87°56'14"W A DISTANCE OF 45.92 FEET;
THENCE S70°54'47"W A DISTANCE OF 30.61 FEET;
THENCE S32°01'32"W A DISTANCE OF 28.13 FEET;
THENCE S12°38'09"E A DISTANCE OF 36.11 FEET TO A POINT ON THE SOUTH LINE OF LOT 9 OF SAID PLAT;
THENCE N89°42'42"W ALONG SAID SOUTH LINE A DISTANCE OF 298.13 FEET TO THE WESTERLY LINE OF SAID PLAT;
THENCE N24°08'14"E ALONG SAID WESTERLY LINE A DISTANCE OF 813.03 FEET TO THE NORTHWEST CORNER OF SAID LOT 16;
THENCE N89°26'12"E ALONG THE NORTH LINE OF SAID LOT 16 A DISTANCE OF 94.99 FEET TO THE POINT OF BEGINNING.
