## Erie Board of Trustees Action Items – January 10, 2012

**Board Approves High Efficiency Washing Machine Rebate Program for 2012** - Applications for the 2012 Town of Erie High Efficiency Washing Machine Rebate Program are now being accepted. The Town approved Eighty (80) rebates of \$50 each. Rebates will be available on a first-come, first-serve basis. The maximum allowable rebate is one per family account. To qualify for a rebate you must meet all of the following requirements:

- You must be a Town of Erie water customer with a current, non-delinquent account. The account must be your primary residence.
- The HE washing machine must have been purchased on or after March 4, 2008
- The machine must be installed at the address on your water bill and must remain in the possession of the original purchaser, or remain at the original installation address for at least one year from the date of purchase. Leased washers are ineligible for a rebate.
- The machine must be a qualifying model listed on the [www.energystar.gov](http://www.energystar.gov) website.

To apply for your rebate:

- Purchase and install an approved ENERGY STAR® qualified clothes washer. Rebates are not obtainable until installation is complete.
- Submit the rebate application (which includes the Affidavit of Lawful Presence in the U.S. that is required by House Bill 06S-1023 signed into law on July 31, 2006) along with the following required documentation:
- A legible copy of the ID required by the Affidavit of Lawful Presence in the U.S. Acceptable types of ID are listed on the rebate application.
- Your original receipt for the qualified washer, showing the date of purchase, make and model, installation date and installation location. Include a self-stamped, addressed envelope if you want your receipt returned.
- A copy of your latest Town of Erie utility bill.

Submission of an application does not guarantee a rebate. Rebates will be processed on a first-come, first-serve basis until the allotment is exhausted. All originals will be returned

**Board Approves Rezoning of Samarchuck Property** – The Board approved an ordinance on First Reading and as an emergency, rezoning the Samarchuck property from AG/OS – Agricultural/Open Space to RR – Rural Residential. The property is approximately 4.7 acres in size and located at 3792 North 119<sup>th</sup> Street in Erie. The Planning Commission recommended approval of the applicant's request for rezoning during their January 4, 2012 meeting.
