Additional Stipulations or Requirements:

- * PROJECTS REQUIRING PAVED ACCESS SHALL HAVE THE PAVING COMPLETED PRIOR TO ANY SITE WORK
- * ANY PROJECTS GREATER THAN ONE ACRE SHALL HAVE A GRADING AND STORMWATER QUALITY PERMIT

LANE/ALLEY CLOSURES LIMITED TO BETWEEN THE HOURS OF 9:00AM - 4:00PM

PAVEMENT MUST BE CLEARED OF DEBRIS AND DIRT PRIOR TO REOPENING

CONTRACTOR MUST FOLLOW TOWN STANDARD DETAIL ST10 FOR TRENCH PATCH

ANY ROAD CUT MUST BE TEMPORARY PATCHED EACH NIGHT AND ROAD REOPENED BY 4PM

MATERIALS MUST BE STORED IN SUCH A WAY AS TO

- A) NOT BE EXPOSED TO STORMWATER
- B) NOT BE STORED WITHIN THE RIGHT OF WAY
- A) NOT IMPEDE TRAFFIC FLOW

- * CONTRACTOR MUST NOTIFY ALL PROPERTY OWNERS IMPACTED BY AN ALLEY/ROAD CLOSURE AND ENSURE THEY HAVE ACCESS TO THEIR PROPERTY

* No boring operations allowed on Friday unless it's an emergency.

* If boring, you must have the approval of the Public Works D&C Supervisor at least 2 days prior to planned boring.

* If the Town is needed to perform a standby due to the proximity of their project and the Town's utility, (determined by locates), the standby will need to be scheduled accordingly with Public Works between the hours of 7:00 AM and 3:30 PM. Any time beyond those hours will be billed to the contractor at 1.5 times the hourly rate.

1. The above named Company shall be responsible for all utility repairs, including water leaks, which develop. (Per Construction Standards, Two-Year Warranty Period applies)
2. All contractors (prime and sub-contractors) shall be licensed with the Town of Erie.
3. The above named Company shall be responsible for acceptable back-fill and compaction of all excavations, as well as immediate repair of all subsidence occurring within the excavated area.
4. Any excavated areas left open overnight must be barricaded and warning devices erected. Permits for areas within the Town of Erie's right-of-ways must be accompanied by Traffic Control Plans for approval.
5. All excavations and repairs to excavations must be inspected by the Town of Erie's Engineering Division Construction Inspector prior to backfill and shall meet current adopted Construction Standards.
6. Contractor shall attach a copy of the work plan to this application.
7. Any excavations involving asphalt shall be repaired and/or replaced with hot mix within seven (7) days, weather permitting.
8. Contractor shall provide a minimum of two (2) working days notice prior to starting construction.
9. Other requirements, if deemed necessary, shall be attached to this application.
