OVERALL BOUNDARY DESCRIPTION

LOCATED IN THE SOUTHEAST QUARTER OF SECTION 25, TOWNSHIP 1 NORTH, RANGE 69 WEST OF THE SIXTH PRINCIPAL MERIDIAN, TOWN OF ERIE, COUNTY OF BOULDER, STATE OF COLORADO, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE EAST QUARTER CORNER OF SAID SOUTHEAST QUARTER OF SECTION 25;

THENCE NORTH 89°42'40" EAST ALONG THE NORTH LINE OF SAID SOUTHEAST QUARTER A DISTANCE OF 95.08 FEET;

THENCE SOUTH 00°17'20" WEST A DISTANCE OF 40.00 FEET TO THE POINT OF BEGINNING;

THENCE SOUTH 00°21'26" WEST A DISTANCE OF 807.74 FEET;

THENCE NORTH 89°38'34" WEST A DISTANCE OF 1,083.18 FEET;

THENCE ALONG A NON-TANGENT CURVE TO THE RIGHT HAVING A CENTRAL ANGLE OF 26°22'54", A RADIUS OF 440.00 FEET, AN ARC LENGTH OF 202.60 FEET AND A CHORD THAT BEARS NORTH 12°50'01" WEST A DISTANCE OF 200.81 FEET;

THENCE NORTH 00°21'26" EAST A DISTANCE OF 580.93 FEET TO A POINT OF CURVATURE;

THENCE ALONG A CURVE TO THE RIGHT HAVING A CENTRAL ANGLE OF 89°55'54", A RADIUS OF 15.00 FEET, AN ARC LENGTH OF 23.54 FEET AND A CHORD THAT BEARS NORTH 45°19'23" EAST A DISTANCE OF 21.20 FEET;

THENCE SOUTH 89°42'40" EAST A DISTANCE OF 749.48 FEET TO A POINT OF CURVATURE;

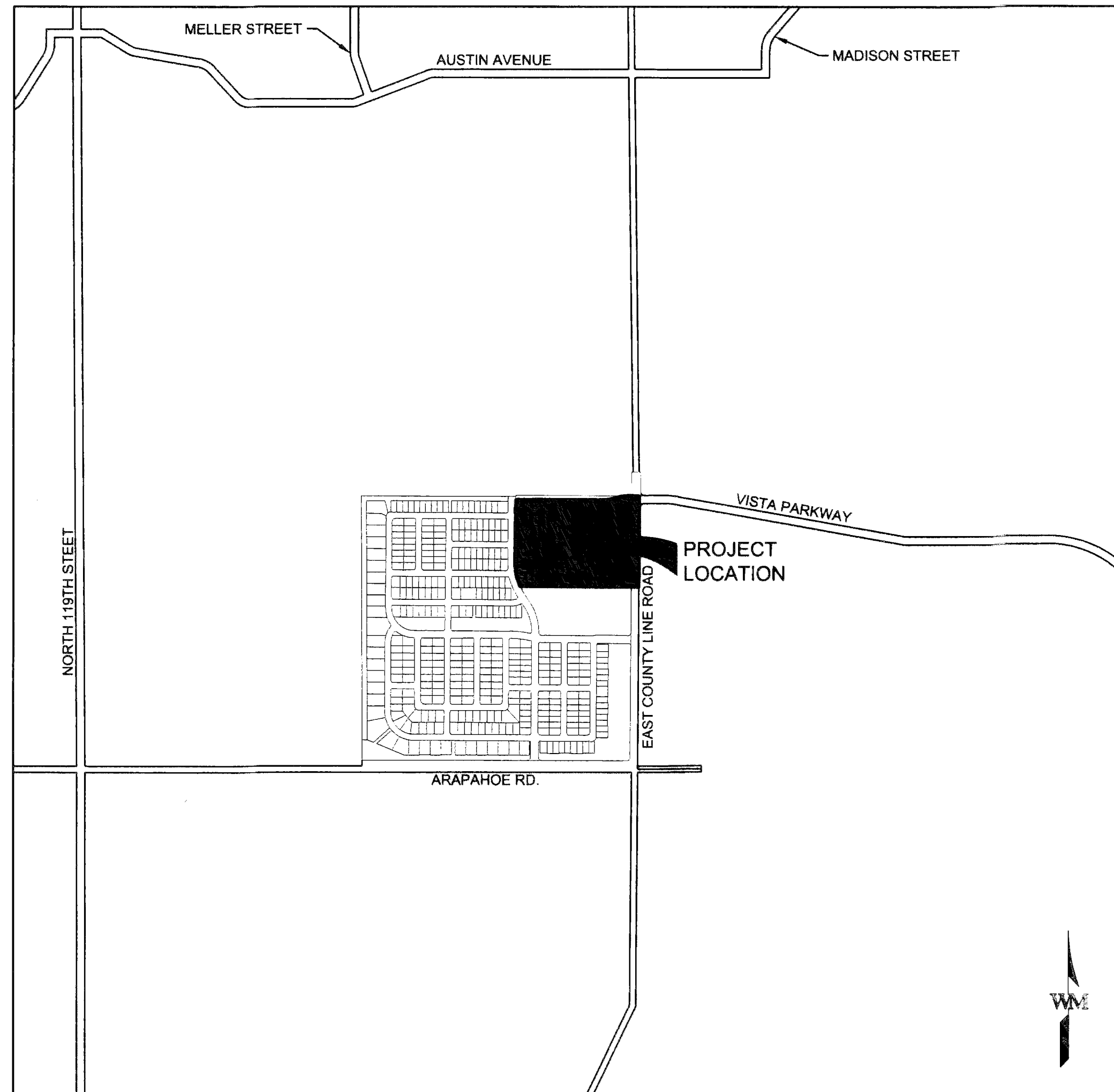
THENCE ALONG A CURVE TO THE LEFT HAVING A CENTRAL ANGLE OF 16°41'08", A RADIUS OF 515.00 FEET, AN ARC LENGTH OF 149.98 FEET AND A CHORD THAT BEARS NORTH 81°56'46" EAST A DISTANCE OF 149.45 FEET TO A POINT OF CURVATURE;

THENCE ALONG A REVERSE CURVE TO THE RIGHT HAVING A CENTRAL ANGLE OF 16°41'08", A RADIUS OF 435.00 FEET, AN ARC LENGTH OF 126.68 FEET AND A CHORD THAT BEARS NORTH 81°56'46" EAST A DISTANCE OF 126.23 FEET;

THENCE SOUTH 89°42'40" EAST A DISTANCE OF 66.80 FEET TO A POINT OF CURVATURE;

THENCE ALONG A CURVE TO THE RIGHT HAVING A CENTRAL ANGLE OF 90°04'06", A RADIUS OF 25.00 FEET, AN ARC LENGTH OF 39.30 FEET AND A CHORD THAT BEARS SOUTH 44°40'37" EAST A DISTANCE OF 35.38 FEET TO THE POINT OF BEGINNING;

SAID PARCEL CONTAINS AN AREA OF 900,155 SQUARE FEET, OR 20.665 ACRES, MORE OR LESS. ALL LINEAL DISTANCE UNITS ARE REPRESENTED IN U.S. SURVEY FEET.
